Site Visit to Tuen Mun – Chek Lap Kok Link on 5 March 2016 (Southern Connection Viaduct Section) (TMCLKL)

AES organised a technical visit to Tuen Mun – Chek Lap Kok Link (Southern Connection Viaduct section) on 5 March 2016 with the support from Deming ProDevelop Consultant Agency Ltd. There were around 25 participants joining this visit.

The representative of the Highways Department gave an overview of the project status and shared some of the political and engineering uncertainties involved during the implementation in the Information Centre before the tour.

The TM-CLKL comprises a 9 km long dual 2-lane carriageway between Tuen Mun and North Lantau. The alignment commences at a connection with the North Lantau Highway (NLH) at Tai Ho of Lantau. It heads northwest on a 1.6 km long sea viaduct to the Hong Kong Boundary Crossing Facilities (HKBCF) near the HKIA.

The construction environment is complicated – typhoons, crisscross navigation, airport height restrictions, high environmental standards.

This visit enabled members to acquire better understanding of the complexity of the project.

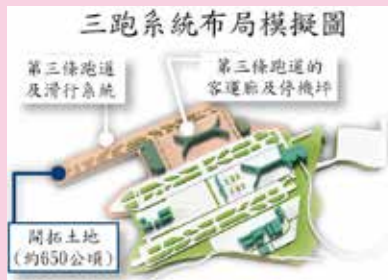
